7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Melway Paving Company, Inc., for the 2016 Summit County 405 Resurfacing Program, in**
9 **an amount not to exceed \$1,374,477.85, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held April 20, 2016, awarded a
12 construction contract with Melway Paving Company, Inc., for the 2016 Summit County 405
13 Resurfacing Program, in an amount not to exceed \$1,374,477.85, subject to confirmation by
14 County Council; and

16 WHEREAS, Council finds and determines after reviewing all pertinent information that
17 the aforementioned construction contract with Melway Paving Company, Inc. is necessary and in
18 the best interest of the County of Summit;

20 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a construction contract with Melway Paving
26 Company, Inc., for the 2016 Summit County 405 Resurfacing Program, in an amount not to
27 exceed \$1,374,477.85, is hereby confirmed and the County Executive is hereby authorized to
28 execute such construction contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide for the 2016 Summit County 405 Resurfacing Program.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.


