7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Montrose Ford, Inc. for five new vehicles, under CUE pricing, in a total amount not to**  
9 **exceed \$142,720.60, for the Sheriff, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held April 13, 2016, awarded a purchase  
12 contract with Montrose Ford, Inc. for five 2017 Ford AWD marked Explorer SUVs, under CUE  
13 pricing, in a total amount not to exceed \$142,720.60, subject to confirmation by County Council;

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
17 that the aforementioned purchase contract with Montrose Ford, Inc., is necessary and in the best  
18 interest of the County of Summit;

20 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a purchase contract with Montrose Ford, Inc. for  
26 five 2017 Ford AWD marked Explorer SUVs, under CUE pricing, in a total amount not to  
27 exceed \$142,720.60, is hereby confirmed and the County Executive is hereby authorized to  
28 execute such purchase contract.



34 replace unreliable vehicles for the Sheriff's Office in 2016.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
