14 WHEREAS, the Board of Control, at its meeting held May 4, 2016, awarded a renewal
15 (third of five) of a professional services contract with The Young Men's Christian Association of
16 Akron, Ohio, dba Akron Area YMCA, to provide child care services at the Ohio Means Jobs
17 Summit County facility, located at 1040 E. Tallmadge Avenue, Akron, Ohio 44310, in Council
18 District 2, for the period 7/1/16 through 6/30/17, in an amount not to exceed \$67,346.58, subject
19 to confirmation by County Council; and

21 WHEREAS, this Council finds and determines after reviewing all pertinent information
22 that the aforementioned renewal is necessary and in the best interest of the County of Summit;

29 The award by the Board of Control of a renewal (third of five) of a professional services
30 contract with The Young Men's Christian Association of Akron, Ohio, dba Akron Area YMCA,
31 to provide child care services at the Ohio Means Jobs Summit County facility, located at 1040 E.
32 Tallmadge Avenue, Akron, Ohio 44310, in Council District 2, for the period 7/1/16 through
33 6/30/17, in an amount not to exceed \$67,346.58, is hereby confirmed and the County Executive
34 is hereby authorized to execute such professional contract renewal.

38 This Resolution is hereby declared an emergency in the health, safety and welfare of the
39 citizens of the County of Summit, and for the further reason to immediately provide for child
40 care services at the Ohio Means Jobs Summit County facility effective 7/1/16.
