11 **Department of Law, Insurance, and Risk Management- Division of Emergency**

14 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
15 requires this Council's authorization for the County Executive to advertise for bids; and

17 WHEREAS, the County Executive wishes to advertise for bids for a service/support
18 agreement that shall include 24/7/365 reach-back technical support for Smith Detection
19 Equipment owned by the Summit County Special Operations Team, for the period ending
20 3/31/2018, for an estimated total cost not to exceed \$90,959.60; and

22 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

24 WHEREAS this Council finds and determines, after reviewing all pertinent information
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
26 advertise for bids for the aforementioned service/support agreement;

33 The County Executive is authorized to advertise for bids for a service/support agreement
34 that shall include 24/7/365 reach-back technical support for Smith Detection Equipment owned
35 by the Summit County Special Operations Team, for the period ending 3/31/2018, for an
36 estimated total cost not to exceed \$90,959.60.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
42 Executive to immediately advertise for bids for the necessary service/support agreement for
43 reach-back technical support for Smith Detection Equipment owned by the Summit County
44 Special Operations Team.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
