A Resolution, authorizing the County Executive to execute Amendment #1 to a subgrant agreement with the Ohio Department of Job and Family Services for grants for the operation of workforce development activities for Local Area 2 received by the County Executive's Department of Job and Family Services during State Fiscal Year 2016 (7/1/16 to 6/30/17), and setting forth the conditions and reliances upon which the County is entering into said Amendment #1, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, Section 5101.21 of the Ohio Revised Code provides that the Ohio Department of Job and Family Services may only make grants to counties through subgrant agreements described in that Section; and

WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio Department of Job and Family Services developed a standard subgrant agreement to be executed by the Executive or Commissioners of each county prior to receiving Department of Job and Family Services grant funds; and

WHEREAS, pursuant to Resolution No. 2015-357, this Council approved a subgrant agreement for the operation of workforce development activities received by the County Department of Job and Family Services for State Fiscal Year ("SFY") 2016 (7/1/15 to 6/30/16); and

WHEREAS, the County Department of Job and Family Services has received from the State a standard Amendment #1 to the aforementioned subgrant agreement to continue the same for SFY 2017 (7/1/16 through 6/30/17) that sets forth the rights and responsibilities of the Ohio Department of Job and Family Services and the County Department of Job and Family Services in relation to any grant for workforce development activities, including, but not limited to, the Workforce Investment Opportunity Act, the Wagner-Peyser Act, and Temporary Assistance to Needy Families programs relating to workforce development, that are awarded for SFY 2017; and

WHEREAS, given the uncertainty that exists about the State of Ohio's ability to implement its new Comprehensive Case Management and Employment Program ("CCMEP") using Workforce Investment Opportunity Act funds, it is necessary to condition the County's execution of the subgrant agreement on (i) the State of Ohio's implementation and operation of CCMEP in the manner and fashion identified in certain correspondence between the State of Ohio and the U.S. Department of Labor, attached hereto as Exhibits A and B, (ii) the representations in the correspondence from Ohio Department of Job and Family Services Director Cynthia Dungey, attached hereto as Exhibit C, and (iii) the State's implementation and operation of CCMEP in a manner and fashion consistent with the Workforce Innovation Opportunity Act and further guidance and directive from the U.S. Department of Labor; and

WHEREAS this Council finds and determines after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute said Amendment #1 to the subgrant agreement for SFY 2017;

WHEREAS, in determining that authorizing the County Executive to execute said Amendment #1 is in the best interest of the County, this Council has relied upon the representations made by the State of Ohio in the correspondence attached hereto as Exhibits B and C; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The County Executive is authorized to execute Amendment #1 to the subgrant agreement with the Ohio Department of Job and Family Services for grants for the operation of workforce development activities received by the County Department of Job and Family Services for State Fiscal Year 2017 (7/1/16 through 6/30/17). A copy of said Amendment #1 to the subgrant agreement is attached hereto as Exhibit D and incorporated herein by reference.

SECTION 2

The County Executive is further authorized and directed to communicate to the State of Ohio Department of Job and Family Services upon execution and submittal of said Amendment #1, that the execution of the same is conditioned on the conditions set forth above, that the County has relied on the representations made by the State of Ohio in the correspondence attached hereto as Exhibits B and C, and that the County will construe the State's issuance/release of funds to implement CCMEP to the Area 2 WDB, its Fiscal Agent, and/or its member Counties- Summit and Medina- to constitute acknowledgment, acceptance and consent to the conditions and reliances set forth above.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it is necessary to immediately execute said Amendment #1 to the subgrant agreement so that the County Executive's Department of Job and Family Services is eligible to be awarded grant funds from the Ohio Department of Job and Family Services for SFY 2017.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.

SECTION 5

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirement, including Section 121.22 of the Ohio Revised Code.
