7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of a**
8 **professional service contract with Wichert Insurance Services, Inc. dba Wichert Insurance**
9 **to provide brokerage services for the County's property, liability and boiler and machinery**
10 **insurance program, for a one-year term, from 7/1/16 through 6/30/17, in an amount not to**
11 **exceed \$35,000.00, for the Executive's Department of Law, Insurance and Risk**
12 **Management, and declaring an emergency.**

13
14 WHEREAS, the County Executive's Department of Finance and Budget's Division of
15 Purchasing sent a Request for Proposals to five vendors for brokerage services for the County
16 property, liability and boiler and machinery insurance program, for a one-year term, from 7/1/15
17 through 6/30/16, to which two vendors responded; and

18
19 WHEREAS, County Council previously adopted Resolution No. 2015-227, which
20 authorized the County Executive to execute a professional service contract with Wichert
21 Insurance Services, Inc. dba Wichert Insurance, subject to the approval of the Board of Control,
22 to provide brokerage services for the County's property, liability and boiler and machinery
23 insurance program, for a one-year term, from 7/1/15 through 6/30/16, in an amount not to exceed
24 \$30,000.00, with two options to renew for an additional one-year term; and

26 WHEREAS, Council also previously adopted Resolution No. 2016-106, which confirmed
27 an award by the Board of Control authorizing the purchase of contracts for various types of
28 insurance, for a one-year term, from 4/15/16 through 4/14/17, in an amount not to exceed
29 \$825,932.00, payable through Wichert Insurance Services, Inc. dba Wichert Insurance, as a Best
30 Practical Source; and

32 WHEREAS, the Board of Control, at its meeting held June 8, 2016, awarded a renewal
33 (first of two) of a professional service contract with Wichert Insurance Services, Inc. dba
34 Wichert Insurance to provide brokerage services for the County's property, liability and boiler
35 and machinery insurance program, for a one-year term, from 7/1/16 through 6/30/17, in an
36 amount not to exceed \$35,000.00, subject to confirmation by County Council; and

38 WHEREAS, because Wichert Insurance Services, Inc. dba Wichert Insurance has been
39 directly paid in excess of \$800,000.00, Council approval of its professional service contract is
40 necessary; and

42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
43 that it the aforementioned professional service contract with Wichert Insurance Services, Inc.,
44 dba Wichert Insurance is necessary and in the best interest in the County of Summit;

46 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
47 State of Ohio, that:

51 The County Executive is hereby authorized to execute a professional service contract
52 with Wichert Insurance Services, Inc. dba Wichert Insurance to provide brokerage services for

6 the County's property, liability and boiler and machinery insurance program, for a one-year term,
7 from 7/1/16 through 6/30/17, in an amount not to exceed \$35,000.00, with two options to renew
8 for an additional one-year term.

12 This Resolution is hereby declared to be an emergency in the interest of the health,
13 safety, and welfare of the citizens of the County of Summit, and for the further reason to
14 immediately provide brokerage services for the County's property, liability and boiler and
15 machinery insurance in 2016-2017.

17 SECTION 3

19 Provided this Resolution receives the affirmative vote of eight members, it shall take
20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
21 effect and be in force at the earliest time provided by law.

25 It is found and determined that all formal actions of this Council concerning and relating
26 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
27 deliberations of this Council and of any of its committees that resulted in such formal action,
28 were in meetings open to the public, in compliance with all legal requirements, including Section
29 121.22 of the Ohio Revised Code.
