13 WHEREAS, the Board of Control, at its meeting held June 8, 2016, awarded a
14 professional service contract with Oriana House, Inc., as a Best Practical Source, for community
15 corrections services to divert misdemeanor offenders from jail, for the period 7/1/16 through
16 6/30/17, in an amount not to exceed \$425,025.00, subject to confirmation by County Council;

19 WHEREAS, this Council finds and determines after reviewing all pertinent information,
20 that the aforementioned professional service contract with Oriana House, Inc. is necessary and in
21 the best interest of the County of Summit;

28 The award by the Board of Control of a professional service contract with Oriana House,
29 Inc., as a Best Practical Source, for community corrections services to divert misdemeanor
30 offenders from jail, for the period 7/1/16 through 6/30/17, in an amount not to exceed
31 \$425,025.00 is hereby confirmed and the County Executive is hereby authorized to execute such
32 professional service contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide for community corrections services to divert misdemeanor offenders from jail effective


