7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of**
8 **professional services contracts with certain providers for Workforce Innovation and**
9 **Opportunity Act youth agreements, for the period 7/1/16 through 6/30/17, in a total amount**
10 **not to exceed \$652,000.00, for the Executive's Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2015-244, which
14 confirmed an award by the Board of Control of professional service contracts with certain
15 providers for Workforce Innovation and Opportunity Act youth agreements, for the period 7/1/15
16 through 6/30/16, with two options to renew for a one-year period, in a total amount not to exceed
17 \$625,000.00; and

19 WHEREAS, the Board of Control, at its meeting held June 1, 2016, awarded a renewal
20 (first of two) of professional service contracts with certain providers for Workforce Innovation
21 and Opportunity Act ("WIOA") youth agreements, for the period 7/1/16 through 6/30/17, in an
22 amount not to exceed \$652,000.00, subject to confirmation by County Council; and

24 WHEREAS, the WIOA agreements provide for out-of-school and in-and-out-of-school
25 youth employment and educational services;

27 WHEREAS, a list of providers is attached as Exhibit A; and

29 WHEREAS, this Council finds and determines after reviewing all pertinent information
30 that the aforementioned renewal of professional service contracts with certain providers are
31 necessary and in the best interest of the County of Summit;

33 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The award by the Board of Control of a renewal (first of two) of professional service
39 contracts with certain providers, as outlined in the attached Exhibit A, for Workforce Innovation
40 and Opportunity Act youth agreements, for the period 7/1/16 through 6/30/17, in a total amount
41 not to exceed \$652,000.00, is hereby authorized and the County Executive is hereby authorized
42 to execute the renewals of the aforementioned professional service contracts as outlined in
43 Exhibit A.

48 welfare of the citizens of the County of Summit, and for the further reason to immediately
