12 WHEREAS, the Board of Control, at its meeting held June 8, 2016, awarded a
13 professional service contract to Perfecting Saints Heart to Heart Ministries, Inc., for adult ex-
14 offender services, for the period 7/1/16 through 9/30/17, in an amount not to exceed
15 \$150,000.00, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information,
18 that the aforementioned professional service contract with Perfecting Saints Heart to Heart
19 Ministries, Inc. is necessary and in the best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with Perfecting
27 Saints Heart to Heart Ministries., for adult ex-offender services, for the period 7/1/16 through
28 9/30/17, in an amount not to exceed \$150,000.00 is hereby confirmed and the County Executive
29 is hereby authorized to execute such professional service contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for adult ex-offender service effective 7/1/16.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
