7 **A Resolution increasing existing appropriations within the operating budget of the Summit**

11 WHEREAS, the Summit County Developmental Disabilities Board entered into a
12 Summer Youth Employment Program agreement with the County of Summit, Executive's
13 Department of Job and Family Services, to provide monitoring services and work readiness skills
14 classes, for the period 5/1/16 through 9/30/16, in an amount not to exceed \$344,000.00; and

16 WHEREAS, it is necessary to increase existing appropriations in order to meet the needs
17 of the Summit County Developmental Disabilities Board; and

19 WHEREAS, this Council finds and determines after reviewing all pertinent information,
20 that it is necessary to increase existing appropriations in the amount of \$344,000.00 within the
21 operating budget of the Summit County Developmental Disabilities Board and in the best
22 interest of the County of Summit;




