13 WHEREAS, the Board of Control, at its meeting on held May 25, 2016, awarded a
14 professional service contract with Advize X Technologies, Inc., for the capacity and performance
15 upgrade for production and disaster recovery storage, under State Term Pricing in an amount not
16 to exceed \$148,156.00, approved by the IT Board on May 19, 2016, subject to confirmation by
17 County Council; and

19 WHEREAS, it is necessary to appropriate funds in the amount of \$148,156.00 for the
20 aforementioned professional service contract; and

22 WHEREAS, this Council finds and determines after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to confirm the award of the
24 aforementioned professional service contract with AdvizeX Technologies, Inc. and to
25 appropriate funds for the necessary upgrades to the County network servers;
