7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the Ohio Department of Public Safety's Office of Criminal Justice**
9 **Services, of a Drug Law Enforcement Fund grant, for the period 7/1/16 through 6/30/17, in**
10 **the amount of \$250,000.00, with a 25% local cash match requirement of \$83,333.33, and**
11 **appropriating funds, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services,
14 of a Drug Law Enforcement Fund ("ODPS-OCJS") has awarded the Sheriff's Office a Drug Law
15 Enforcement Fund ("DLEF") grant, for the period 7/1/16 through 6/30/17, in the amount of
16 \$250,000.00, with a 25% local cash match requirement of \$83,333.33, for a total amount of
17 \$333,333.33; and

19 WHEREAS, this DLEF grant will fund a countywide drug unit task force which will
20 specifically target the manufacture, distribution and acquisition of illegal drugs in Summit
21 County; and

23 WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit
24 County Drug Unit account; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to authorize the Executive to execute
28 any documents necessary to accept the award of the aforementioned DLEF grant from the
29 ODPS-OCJS, and to appropriate funds;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept
37 the award by the Ohio Department of Public Safety's Office of Criminal Justice Services
38 ("ODPS-OCJS") of a Drug Law Enforcement Fund ("DLEF") grant, for the period 7/1/16
39 through 6/30/17, in the amount of \$250,000.00, with a 25% local cash match requirement of
40 \$83,333.33, for a total grant award of \$333,333.33.
