WHEREAS, this Council previously adopted Resolution No. 2016-097, authorizing the County Executive to execute a real estate purchase agreement with Rubber City Arches Land Co., LLC for the purchase of real property at 492 and 500 Grant Street and appropriated funds totaling \$550,000.00 for said purchase; and

WHEREAS, this Council previously approved Resolution No. 2016-196, authorizing the Executive to execute a contract with Krumroy-Cozad Construction Corporation, for the Board of Elections Renovation Project, located at 500 Grant Street, Akron, Ohio 44311, in Council District 4, in an amount not to exceed \$456,136.00, and appropriated funds for said contract and additional project expenses, including but not limited to, fire and security alarms, cameras and IT infrastructure, in the amount of \$510,000.00 for the aforementioned Project; and

WHEREAS, the Board of Elections has submitted to the Executive a list of equipment and furnishings necessary to properly and efficiently conduct early voting at the Early Voting Center, a listing of which is set forth on Exhibit A, and the Executive, with input from the Office of Information Technology, has determined the list of equipment and furnishings is necessary and proper; and
