7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with The Amazing Cloud, LLC, as a Best Practical Source, for Disaster**
9 **Recovery as a Service, for a three-year term, from 1/1/21 through 12/31/23, for a total**
10 **not to exceed amount of \$225,000.00 for the Office of Information Technology, and**
11 **declaring an emergency.**

13 WHEREAS, Disaster Recovery as a Service (“DRaaS”) is the replication and hosting
14 of physical or virtual servers by a third party to provide failover in the event of a natural
15 catastrophe, power outage or another type of business disruption; and

16
17 WHEREAS, the County requires the management of the County’s DRaaS hardware
18 in the Fairlawn Gig datacenter; and

19
20 WHEREAS, The Amazing Cloud, LLC is a Best Practical Source as they are the only
21 company capable of servicing the equipment at the Fairlawn Gig data center and they are the
22 only company that can utilize the connection from the Ohio Building to the Fairlawn Gig
23 data center; and

25 WHEREAS, the Office of Information Technology recommends that the County
26 enter into a professional service contract with The Amazing Cloud, LLC for DRaaS, for a
27 three-year term, from 1/1/21 through 12/31/23, for \$6,250.00 per month, for a total not to
28 exceed amount of \$225,000.00 for the three-year term; and

30 WHEREAS, the IT Board, at its meeting held November 19, 2020, approved the
31 aforementioned professional service contract with The Amazing Cloud, LLC for DRaaS; and

33 WHEREAS, the Board of Control, at its meeting held December 2, 2020, awarded the
34 aforementioned professional service contract with The Amazing Cloud, LLC for DRaaS, as a
35 Best Practical Source, subject to confirmation by this Council; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent
38 information, that the aforementioned professional service contract with The Amazing Cloud,
39 LLC is necessary and in the best interest of the County of Summit;

41 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit,

9 contract and any other necessary related documents.

12 This Resolution is hereby declared an emergency in the interest of the health, safety,
13 and welfare of the residents of the County of Summit and for the further reason of
14 immediately authorizing a necessary professional service contract for DRaaS.

18 Provided this Resolution receives the affirmative vote of eight members, it shall take
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
20 effect and be in force at the earliest time provided by law.






