7 **A Resolution confirming the award by the Board of Control for a renewal (fourth and**
8 **final) of a professional service contract with Oriana House, Inc. for community corrections**
9 **services, which shall include the operation of the County of Summit Community**
10 **Alternative Sentencing Center, for a one year term, from 1/1/21 through 12/31/21, in an**
11 **amount not to exceed \$6,946,915.68, for the Executive’s Department of Law and Risk**
12 **Management–Division of Public Safety, and declaring an emergency.**

13
14 WHEREAS, this Council previously adopted Resolution No. 2016-433, which confirmed
15 an award by the Board of Control a professional service contract with Oriana House, Inc. for day
16 reporting, driver intervention, home incarceration, multiple offender, pretrial services and
17 residential community corrections programs, for the period 1/1/17 through 12/31/17, in an
18 amount not to exceed \$5,921,097.39, with four options to renew for an additional one-year term,
19 with the cost of any renewal term to be equal to the increase in the Consumer Price Index or
20 three percent, whichever is less; and

21
22 WHEREAS, this Council subsequently adopted Resolution No. 2018-026, which
23 confirmed the award by the Board of Control for a renewal (first of four) of a professional
24 service contract with Oriana House, Inc. for community corrections services, for a one-year term,
25 from 1/1/18 through 12/31/18, in an amount not to exceed \$5,921,097.39; and

26
27 WHEREAS, this Council subsequently adopted Resolution No. 2018-360, which
28 repealed Ordinance Nos. 83-406 and 96-611 designating 40 East Glenwood Avenue, Akron,
29 Ohio 44304 as a County Jail Facility and pursuant to Section 307.932 of the Ohio Revised Code,
30 redesignated and established 40 East Glenwood Avenue as the County of Summit Community
31 Alternative Sentencing Center (“CS-CASC”); and

33 WHEREAS, this Council subsequently adopted Resolution No. 2018-359, which
34 authorized the Executive to execute, subject to the approval of the Board of Control, a renewal
35 (second of four) of the professional service contract with Oriana House, Inc. for community
36 corrections services, which included the operation of the CS-CASC, for a one year term, from
37 1/1/19 through 12/31/19, in an amount not to exceed \$6,571,493.73; and

39 WHEREAS, this Council subsequently adopted Resolution No. 2020-051, which
40 confirmed the award by the Board of Control of a renewal (third of four) of the professional
41 service contract with Oriana House, Inc. for community corrections services, which included the
42 operation of the CS-CASC, for a one year term, from 1/1/20 through 12/31/20, in an amount not
43 to exceed \$6,946,915.68; and

45 WHEREAS, the County wishes to renew (fourth and final) the professional service
46 contract with Oriana House, Inc. for community corrections services, which shall continue to
47 include the operation of the CS-CASC, for a one year term, from 1/1/21 through 12/31/21, in an
48 amount not to exceed \$6,946,915.68; and

50 WHEREAS, the Board of Control, at its December 9, 2020 meeting, awarded the
51 aforementioned professional service contract with Oriana House, Inc. for community corrections

4 program services, including the operation of the CS-CASC, subject to confirmation by this
5 Council; and

7 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
8 that the aforementioned renewal (fourth and final) of the professional service contract with
9 Oriana House, Inc., which shall include the operation of the CS-CASC, is necessary and in the
10 best interest of the County of Summit;

12 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
13 of Ohio, that:

15 SECTION 1

16
17 The award by Board of Control of a renewal (fourth and final) of a professional service
18 contract with Oriana House, Inc., for community corrections services, which shall include the
19 operation of the County of Summit Community Alternative Sentencing Center ("CS-CASC"),
20 for a one year term, from 1/1/21 through 12/31/21, in an amount not to exceed \$6,946,915.68, is
21 hereby approved and the Executive is hereby authorized to execute said professional service
22 contract and any other related necessary documents.

24 SECTION 2

26 This Resolution is hereby declared an emergency in the interest of the health, safety and
27 welfare of the residents of the County of Summit, and for the further reason to immediately
28 allow the provision of community corrections services, including the operation of the CS-CASC,
29 effective 1/1/21.

31 SECTION 3

33 Provided this Resolution receives the affirmative vote of eight members, it shall take
34 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
35 effect and be in force at the earliest time provided by law.

37 SECTION 4

39 It is found and determined that all formal actions of this Council concerning and relating
40 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
41 deliberations of this Council and of any of its committees that resulted in such formal action,
42 were in meetings open to the public, in compliance with all legal requirements, including Section
43 121.22 of the Ohio Revised Code.
