7 **A Resolution authorizing the Executive to execute a grant agreement with the Victim**  
8 **Assistance Program, for a grant for victim assistance services, in an amount not to exceed**  
9 **\$50,000.00, for the year 2021, for the Executive's Department of Finance and Budget, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, this Council previously adopted Resolution No. 2020-010, which authorized  
13 the Executive to execute a grant agreement with the Victim Assistance Program, for a grant for  
14 victim assistance services, in an amount not to exceed \$30,000.00, for the year 2020; and

15  
16 WHEREAS, this Council subsequently adopted Amended Resolution No. 2020-375 as  
17 part of the 2021 General Fund Budget, which appropriated funds in an amount not to exceed  
18 \$50,000.00, for a grant to the Victim Assistance Program for victim assistance services; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
22 execute a grant agreement with the Victim Assistance Program, for the aforementioned grant for  
23 victim assistance services, in an amount not to exceed \$50,000.00, for the year 2021;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that:

28 SECTION 1

30 The Executive is hereby authorized to execute a grant agreement and any other necessary  
31 related documents with the Victim Assistance Program for a grant for victim assistance services,  
32 in an amount not to exceed \$50,000.00, for the year 2021.

34 SECTION 2

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the residents of the County of Summit, and for the further reason that the County  
38 wishes to immediately provide support through a grant to the Victim Assistance Program for  
39 victim assistance services for the year 2021.

41 SECTION 3

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.



10 121.22 of the Ohio Revised Code.


