7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with Oriana House, Inc., as a Best Practical Source, for two full-time case**
9 **managers and one full-time recovery support specialist, to provide support and treatment**
10 **services to Valor Court participants, for a one-year term, from 9/30/20 through 9/29/21, in**
11 **an amount not to exceed \$216,388.49, for the Court of Common Pleas-General Division,**
12 **Adult Probation, and declaring an emergency.**

14 WHEREAS, this Council previously adopted Resolution No. 2020-091, which confirmed
15 the award by the Board of Control of a professional service contract with Oriana House, Inc., as
16 a Best Practical Source, for two full-time case managers and one full-time recovery support
17 specialist, to provide support and treatment services to Valor Court participants, for a one-year
18 term, from 9/30/19 through 9/29/20, in an amount not to exceed \$210,332.00; and

20 WHEREAS, the Court of Common Pleas-General Division, Adult Probation, wishes to
21 enter into a professional service contract with Oriana House, Inc., as a Best Practical Source, for
22 a one-year term, from 9/30/20 through 9/29/21, in an amount not to exceed \$216,388.49, to be
23 funded by a Fiscal Year 2020 Treatment Drug Courts grant from the United States Department
24 of Health and Human Services, Substance Abuse and Mental Health Services Administration
25 ("SAMSHA") for the Valor Court Expansion and Enhancement Project; and

27 WHEREAS, the Board of Control, at its meeting held January 20, 2021, awarded said
28 professional service contract with Oriana House, Inc., as a Best Practical Source, for a one-year
29 term, from 9/30/20 through 9/29/21, in an amount not to exceed \$216,388.49, subject to
30 confirmation by Council; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that the aforementioned renewal of the professional service contract with Oriana House, Inc. is
34 necessary and in the best interest of the County of Summit;

45 confirmed and the Executive is hereby authorized to execute said professional service contract


