7 **A Resolution authorizing the Executive to advertise for bids for the Summit County Ohio**  
8 **Building Roof Replacement Project, located in the City of Akron, in Council District 5, for**  
9 **an estimated total cost not to exceed \$886,500.00, for the Executive's Department of**  
10 **Administrative Services-Physical Plants, and declaring an emergency.**

11  
12 WHEREAS, the existing roofs on the Summit County Ohio Building, located in the City  
13 of Akron, in Council District 5, are 24 and 31 years old respectively, are in poor shape and need  
14 to be replaced; and

15  
16 WHEREAS, the replacement roofs will have 20-year warranties; and

17  
18 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
19 requires this Council's authorization for the Executive to advertise for bids; and

20  
21 WHEREAS, the Executive wishes to advertise for bids for the aforementioned  
22 replacement roofs, the Summit County Ohio Building Roof Replacement Project (the "Project"),  
23 for an estimated total cost not to exceed \$886,500.00; and

25 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's Office;

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 advertise for bids for the Project, for an estimated total cost not to exceed \$886,500.00;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The Executive is hereby authorized to advertise for bids for the Summit County Ohio  
38 Building Roof Replacement Project, located in the City of Akron, in Council District 5, for an  
39 estimated total cost not to exceed \$886,500.00.

43 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
44 of the residents of the County of Summit, and for the further reason that it authorizes the  
45 Executive to immediately advertisement for bids for necessary new roofs for the Summit County  
46 Ohio Building.




