7 **A Resolution authorizing the Executive to advertise for bids for the Board of Elections**
8 **Telecom Wiring Upgrade Project, located in the City of Akron, in Council District 4, for an**
9 **estimated total cost not to exceed \$150,000.00, for the Executive's Department of**
10 **Administrative Services-Physical Plants, and declaring an emergency.**

12 WHEREAS, the Summit County Board of Elections (the "Board") requires that its
13 telephone system be upgraded prior to the May Primary Election in order to utilize Voice over
14 IP; and

15
16 WHEREAS, in order to accommodate the new telecommunication system, the wiring at
17 the Board must be upgraded; and

18
19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
20 requires this Council's authorization for the Executive to advertise for bids; and

22 WHEREAS, the Executive wishes to advertise for bids for the aforementioned Telecom
23 Wiring Upgrade Project, for an estimated total cost not to exceed \$150,000.00; and

25 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's Office;

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that is necessary and in the best interest of the County of Summit to authorize the Executive to
30 advertise for bids for the Board of Elections Telecom Wiring Upgrade Project, for an estimated
31 total cost not to exceed \$150,000.00;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

38 The Executive is hereby authorized to advertise for bids for the Board of Elections
39 Telecom Wiring Upgrade Project, located in the City of Akron, in Council District 4, for an
40 estimated total cost not to exceed \$150,000.00.

44 This Resolution is declared an emergency in the interest of the health, safety, and welfare
45 of the residents of the County of Summit, and for the further reason that it authorizes the
46 Executive to immediately advertisement for bids for a necessary new telecommunications system




