7 **A Resolution ratifying the Executive's signature on the second renewal of an**  
8 **intergovernmental agreement with the City of Akron for direct indictment services to be**  
9 **provided by the Prosecutor, for a one-year term, from 1/1/20 through 12/31/20, and**  
10 **authorizing the Executive to sign the third renewal of an intergovernmental agreement**  
11 **with the City of Akron for direct indictment services to be provided by the Prosecutor, for**  
12 **a one-year term, from 1/1/21 through 12/31/21 and appropriating funds received pursuant**  
13 **to the intergovernmental agreement in the amount of \$310,000.00, for the Prosecutor, and**  
14 **declaring an emergency.**

15  
16 WHEREAS, this Council previously adopted Resolution No. 2018-197, which  
17 authorized the Executive to execute an intergovernmental agreement with the City of Akron for  
18 direct services to be provided by the Prosecutor, for a one-year term, from 1/1/18 through  
19 12/31/18, and appropriated funds received pursuant to the intergovernmental agreement in the  
20 amount of \$310,000.00;

21  
22 WHEREAS, this Council previously adopted Resolution No. 2019-043 which authorized  
23 the Executive to execute the first renewal of the aforementioned intergovernmental agreement  
24 for direct indictment services to be provided by the Prosecutor, for a one-year term, from 1/1/19  
25 through 12/31/19, for a total cost to the City of Akron not to exceed \$310,000.00; and

26  
27 WHEREAS, the County and the City of Akron, after protracted negotiations, entered  
28 into the second renewal of the aforementioned intergovernmental agreement for direct  
29 indictment services to be provided by the Prosecutor, for a one-year term, from 1/1/20 through  
30 12/31/20, for a total cost to the City of Akron not to exceed \$310,000.00; and

32 WHEREAS, the County and the City of Akron wish to enter into the third renewal of the  
33 aforementioned intergovernmental agreement for direct indictment services to be provided by  
34 the Prosecutor, for a one-year term, from 1/1/21 through 12/31/21, for a total cost to the City of  
35 Akron not to exceed \$310,000.00; and

37 WHEREAS, this Council finds and determines, after reviewing all of the pertinent  
38 information, that it is necessary, and in the best interest of this County, to ratify the Executive's  
39 signature of the aforementioned second renewal and to authorize the Executive to execute the  
40 aforementioned third renewal of an intergovernmental agreement with the City of Akron for  
41 direct indictment services to be provided by the Prosecutor.

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,  
44 State of Ohio, that:

48 The signature of the Executive on the second renewal of the intergovernmental  
49 agreement with the City of Akron for direct indictment services to be provided by the  
50 Prosecutor, for a one-year term, from 1/1/20 through 12/31/20 is hereby ratified.

6 The Executive is hereby authorized to execute the first renewal of an intergovernmental  
7 agreement with the City of Akron for direct indictment services to be provided by the  
8 Prosecutor, for a term of one-year, from 1/1/21 through 12/31/21, for a total cost to the City of  
9 Akron not to exceed \$310,000.00.

11 SECTION 3

12  
13 This Resolution is hereby declared an emergency, in the interest of the health, safety and  
14 welfare of the residents of the County of Summit, and for the further reason to immediately  
15 authorize the Executive to execute a necessary renewal of an intergovernmental agreement with  
16 the City of Akron, pursuant to which the Prosecutor will provide direct indictment services to  
17 the City of Akron effective 1/1/21 and to further ratify the Executive's execution of an  
18 intergovernmental agreement with the City of Akron, pursuant to which the Prosecutor provided  
19 direct indictment services to the City of Akron effective 1/1/20 through 12/31/20.

21 SECTION 4

23 Provided this Resolution receives the affirmative vote of eight members, it shall take  
24 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
25 effect, and be in force, at the earliest time provided by law.

27 SECTION 5

29 It is found and determined that all formal actions of this Council concerning and relating  
30 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
31 deliberations of this Council, and of any of its committees, which resulted in such formal action,  
32 were in meetings open to the public, in compliance with all legal requirements, including  
33 Section 121.22 of the Ohio Revised Code.
