7 **A Resolution authorizing the Executive to advertise for bids for two portable multi-sensor**  
8 **wireless monitoring chemical, radiation and meteorological detectors, for the Portage and**  
9 **Mahoning County Type II Hazardous Materials Response Teams for an estimated total**  
10 **cost not to exceed \$135,000.00, for the Executive's Department of Law and Risk**  
11 **Management – Division of Public Safety, Emergency Management Agency and declaring**  
12 **an emergency.**

14 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
15 requires this Council's authorization for the Executive to advertise for bids; and

16  
17 WHEREAS, the Executive wishes to advertise for bids for two portable multi-sensor  
18 wireless monitoring chemical, radiation and meteorological detectors, for the Portage and  
19 Mahoning County Type II Hazardous Materials Response Teams for an estimated total cost not  
20 to exceed \$135,000.00; and

22 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 advertise for bids for two portable multi-sensor wireless monitoring chemical, radiation and  
28 meteorological detectors;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that;

35 The Executive is authorized to advertise for bids for two portable multi-sensor wireless  
36 monitoring chemical, radiation and meteorological detectors, for an estimated total cost not to  
37 exceed \$135,000.00.

41 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
42 of the residents of the County of Summit, and for the further reason that it authorizes the  
43 Executive to immediately advertise for bids in order to procure the necessary equipment within  
44 the grant performance period.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
