7 **A Resolution confirming the award by the Board of Control of a purchase contract with**  
8 **ICOR Technologies for a bomb disposal robot for the Youngstown Bomb Squad, for an**  
9 **amount not to exceed \$62,405.00, for the Executive's Department of Law and Risk**  
10 **Management-Division of Public Safety, Emergency Management Agency and declaring an**  
11 **emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2020-195, which authorized  
14 the Executive to advertise for bids for a bomb disposal robot for the Youngstown Bomb Squad  
15 for an estimated total cost not to exceed \$75,000.00; and

16  
17 WHEREAS, said equipment will be fully grant-funded; and

18  
19 WHEREAS, the County has selected ICOR Technologies, as the sole responsive and  
20 responsible bidder to provide the bomb disposal robot, in an amount not to exceed \$62,405.00;  
21 and

23 WHEREAS, the Board of Control, at its meeting held March 10, 2021, awarded said  
24 purchase contract with ICOR Technologies, subject to confirmation by this Council; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that the aforementioned purchase contract with ICOR Technologies is necessary and in the best  
28 interest of the County of Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that;

35 The award by the Board of Control of a purchase contract with ICOR Technologies for a  
36 bomb disposal robot for the Youngstown Bomb Squad, in an amount not to exceed \$62,405.00,  
37 is hereby confirmed and the Executive is hereby authorized to execute said purchase contract and  
38 any other necessary related documents.

42 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
43 of the residents of the County of Summit, and for the further reason that it authorizes the  
44 Executive to immediately execute a necessary contract in order to procure the necessary  
45 equipment within the grant performance period.

16 121.22 of the Ohio Revised Code.


