8 **A Resolution authorizing the Executive, Prosecutor and Clerk of Courts to establish an**
9 **hourly rate of pay for 8 classified, non-bargaining, employees of \$15.00, for Council and the**
10 **Executive, and declaring an emergency.**

12 WHEREAS, there are presently 8 full time classified non-bargaining employees within
13 the Charter Offices of Executive, Prosecutor and Clerk of Courts who earn less than \$15.00 per
14 hour; and

16 WHEREAS, Section 169.07 of the Codified Ordinances of the County of Summit require
17 this Council's approval to set this hourly rate for these 8 employees; and

19 WHEREAS, the Director of the Department of Human Resources will review the
20 personnel action for the aforementioned changes as required by Section 169.07(b) of the
21 Codified Ordinances; and

23 WHEREAS, the changes will be submitted to the Director of the Department of Finance
24 and Budget for certification of availability of appropriated funds, as required by Section
25 169.07(b) of the Codified Ordinances; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that
28 establishing an hourly rate of pay for 8 classified, non-bargaining, employees of \$15.00, is
29 necessary and in the best interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 This Council hereby determines that it is necessary and in the best interest of the County
37 to immediately authorize the Executive, Prosecutor and Clerk of Courts to establish an hourly
38 rate of pay of \$15.00 for 8 classified, non-bargaining, employees who currently earn less than
39 that amount.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit and for the further reason to immediately
45 properly compensate various employees of the County.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


