7 **A Resolution setting a date for this Council, pursuant to Chapter 709.03 of the Ohio**
8 **Revised Code and Section 125.01(i) of the Codified Ordinances of the County of Summit, to**
9 **conduct a public hearing to consider the annexation of 118.7873 acres of land in Richfield**
10 **Township to the Village of Richfield, for Council, and declaring an emergency.**

12 WHEREAS, this Council, on March 15, 2021 received a petition for annexation of
13 118.7873 acres of land in Richfield Township to the Village of Richfield marked as Exhibit "A";
14 and

16 WHEREAS, pursuant to Chapter 709.03 of the Ohio Revised Code and Section 125.01(i)
17 of the Codified Ordinances of the County of Summit, Council must conduct a public hearing on
18 the aforementioned annexation; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit, pursuant to Chapter 709.03
22 of the Ohio Revised Code and Section 125.01(i) of the Codified Ordinances of the County of
23 Summit, to conduct a public hearing to consider the annexation of 118.7873 acres of land in
24 Richfield Township to the Village of Richfield;

26 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

31 The Clerk of Council shall set the date of May 24, 2021, immediately following the 4:30
32 p.m. Summit County Council meeting for the public hearing on the annexation petition, as
33 required pursuant Chapter 709.03 of the Ohio Revised Code and Section 125.01(i) of the
34 Codified Ordinances of the County of Summit.

38 Notice of this public hearing shall be made by the agent of the petitioner pursuant to
39 Section 125.01(f) of the Codified Ordinances of the County of Summit.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit and for the further reason of immediately
45 allowing the County to comply with the requirements of Chapter 709.03 of the Ohio Revised
46 Code and Section 125.01(i) of the Codified Ordinances of the County of Summit in a timely
47 manner.


