7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Melway Paving Company, Inc. for the 2021 Summit County 422 Resurfacing Program, in**
9 **an amount not to exceed \$911,577.13, for the Engineer, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2020-416, which authorized
12 the Executive to advertise as needed for bridge engineering and construction projects, and
13 pavement maintenance projects, for the Engineer's 2021 Capital Improvements Program, for an
14 estimated total cost not to exceed \$9,117,500.00; and

15
16 WHEREAS, following the receipt and review of bids, the Executive proposes entering
17 into a construction contract with Melway Paving Company, Inc. for the 2021 Summit County
18 422 Resurfacing Program, in an amount not to exceed \$911,577.13; and

20 WHEREAS, the Board of Control, at its meeting held on March 17, 2021, awarded a
21 construction contract with Melway Paving Company, Inc., as the lowest responsive and
22 responsible bidder, for the 2021 Summit County 422 Resurfacing Program, in an amount not to
23 exceed \$911,577.13, subject to confirmation by this Council; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned construction contract with Melway Paving Company, Inc. is necessary
27 and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

34 The award by the Board of Control of a construction contract with Melway Paving
35 Company, Inc., for the 2021 Summit County 422 Resurfacing Program, in an amount not to
36 exceed \$911,577.13, is hereby confirmed and the Executive is hereby authorized to execute said
37 construction contract and any other necessary related documents.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the residents of the County of Summit, and for the further purpose to immediately
43 providing a necessary construction contract for the 2021 Summit County 422 Resurfacing
44 Program.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.


