7 **A Resolution setting a date for this Council, pursuant to Chapter 709.02, 709.021 and**
8 **709.023 of the Ohio Revised Code and Section 125.01(i) of the Codified Ordinances of the**
9 **County of Summit, to conduct a public hearing to consider the annexation of 118.7873**
10 **acres of land in Richfield Township to the Village of Richfield, for Council, and declaring**
11 **an emergency.**

13 WHEREAS, this Council, on March 26, 2021 received a petition for annexation of
14 118.7873 acres of land in Richfield Township to the Village of Richfield marked as Exhibit "A";
15 and

17 WHEREAS, pursuant to Chapter 709.02, 709.021 and 709.023 of the Ohio Revised Code
18 and Section 125.01(i) of the Codified Ordinances of the County of Summit, Council must
19 conduct a public hearing on the aforementioned annexation; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit, pursuant to Chapter 709.02,
23 709.021 and 709.023 of the Ohio Revised Code and Section 125.01(i) of the Codified
24 Ordinances of the County of Summit, to conduct a public hearing to consider the annexation of
25 118.7873 acres of land in Richfield Township to the Village of Richfield;

32 The Clerk of Council shall set the date of May 10, 2021, immediately following the 4:30
33 p.m. Summit County Council meeting for the public hearing on the annexation petition, as
34 required pursuant Chapter 709.02, 709.021 and 709.023 of the Ohio Revised Code and Section
35 125.01(i) of the Codified Ordinances of the County of Summit.

39 Notice of this public hearing shall be made by the agent of the petitioner pursuant to
40 Section 125.01(f) of the Codified Ordinances of the County of Summit.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the citizens of the County of Summit and for the further reason of immediately
46 allowing the County to comply with the requirements of Chapter 709.02, 709.021 and 709.023 of
47 the Ohio Revised Code and Section 125.01(i) of the Codified Ordinances of the County of
48 Summit in a timely manner.


