A Resolution authorizing the Executive to execute any agreements, memorandums of understanding or other necessary related documents to participate with the Village of Mogadore in applying for Ohio Public Works Commission funding for the Sunrise Boulevard East, West Avenue and Pearl Avenue Reconstruction Project, located in the Village of Mogadore, in Council District 8, at a cost to the County not to exceed \$75,000.00, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, the State Capital Improvements Program provides financial assistance through State Issue 1 funds administered by the Ohio Public Works Commission ("OPWC") to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the Village of Mogadore ("Village") is planning to reconstruct infrastructure along Sunrise Boulevard East, West Avenue and Pearl Avenue, including the reconstruction and rehabilitation of sanitary sewer lines (the "Project") because said lines are a source of high inflow and infiltration of storm or ground water; and

WHEREAS, the Project will replace substantially all of the existing infrastructure along Sunrise Boulevard East, West Avenue and Pearl Avenue, including the reconstruction and rehabilitation of approximately 3,300 linear feet of 8" sanitary sewer by cured in place pipe (CIPP) lining along Sunrise Boulevard East, West Avenue, Pearl Avenue, Second Street, Dick Street, and Holcomb Avenue in the Village with a total estimated cost of lining of \$150,000.00; and

WHEREAS, the Village intends to apply to OPWC for partial funding of the Project through State Issue 1 funds, and if the application is accepted, OPWC would provide \$75,000.00 in form a grant (50%); and

WHEREAS, it is anticipated by the Executive that the local cash match, in the amount of \$75,000.00, will be paid to the Village through the Department of Sanitary Sewer Services Sewer Enterprise Fund; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to participate in the Project, and to authorize the Executive to execute any agreements, memorandums of understanding or other necessary related documents to participate with the Village in applying for OPWC funding for the Project;

The terms of the application to be submitted to OPWC, and associated documents, shall maximize the requested amount of State Issue 1 funds, with the remainder of the cost of the improvements to be borne by the Village and the County through the Executive's Department of Sanitary Sewer Services Sewer Enterprise Fund, with the County's share being an amount not to exceed \$75,000.00. The expenditure of an amount not to exceed \$75,000.00 from the Department of Sanitary Services Enterprise Fund as the County's local cash match payable to the Village for the County's portion of the Project is hereby authorized.

SECTION 3

The Clerk of Council is instructed to provide two (2) certified copies of this Resolution to the Department of Sanitary Sewer Services, for submission to the Ohio Public Works Commission with said funding application.

SECTION 4
