7 **A Resolution authorizing the Executive to advertise for bids for the Summit County**  
8 **Courthouse Courtroom, Chambers and Jury Room Paint and Repair Project, in Council**  
9 **District 4, for an estimated total cost not to exceed \$65,000.00, for the Executive’s**  
10 **Department of Administrative Services-Physical Plants Division, and declaring an**  
11 **emergency.**

12  
13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council’s authorization for the Executive to advertise for bids; and

15  
16 WHEREAS, the courtroom currently occupied by Honorable Judge Christine Croce  
17 needs repairs to the cracked ceiling, damaged walls, peeling wallpaper and discolored, faded  
18 paint; and

19  
20 WHEREAS, the Summit County Courthouse Courtroom, Chambers and Jury Room Paint  
21 and Repair Project (the “Project”) will strip paint off of the wooden walls in the courtroom, strip  
22 wallpaper and paint off of all the walls in the Judge’s chambers, jury room and common area,  
23 repair and paint the plaster on the courtroom ceiling and perform all wall repairs as needed; and

25 WHEREAS, the Executive wishes to advertise for bids for the Project, in Council District  
26 4, for an estimated total cost not to exceed \$65,000.00; and

28 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council’s office;  
29 and

31 WHEREAS this Council finds and determines, after reviewing all pertinent information,  
32 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
33 advertise for bids for the Project;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that:

38 SECTION 1

40 The Executive is authorized to advertise for bids for the Summit County Courthouse  
41 Courtroom, Chambers and Jury Room Paint and Repair project, in Council District 4, for an  
42 estimated total cost not to exceed \$65,000.00.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and  
47 welfare of the residents of the County of Summit, and for the further reason that it authorizes the  
48 Executive to immediately advertise for bids for the aforementioned renovation project, in order  
49 for the project to proceed as expeditiously as possible.

16 121.22 of the Ohio Revised Code.


