7 **A Resolution authorizing the Executive to execute a renewal (first of two) of a One-Stop**
8 **Operator Services contract with the Summit and Medina Workforce Area Council of**
9 **Governments, pursuant to which the Executive's Department of Job and Family Services**
10 **will provide One-Stop Operator services at the Ohio Means Jobs Summit County Center,**
11 **for a one-year term, from 7/1/21 to 6/30/22, for which the County shall be paid an amount**
12 **not to exceed \$228,110.00, for the Executive's Department of Job and Family Services, and**
13 **declaring an emergency.**

14
15 WHEREAS, the U.S. Department of Labor's Employment and Training Administration
16 funds a network of American Job Centers ("AJCs") to provide free employment assistance to job
17 seekers at AJC network locations across the United States; and

18
19 WHEREAS, pursuant to the requirements of Workforce Innovation and Opportunity Act
20 of 2014 (the "WIOA") Section 121(d)(2)(A), Local Workforce Areas must competitively procure
21 the Operators of AJCs; and

23 WHEREAS, pursuant to requirements of WIOA, and on the behalf of the
24 Summit/Medina Workforce Development Board (the "WDB"), the Summit and Medina
25 Workforce Area Council of Governments (the "SAMWA COG"), which serves as the Ohio
26 Workforce Area 2 ("Area 2") staff, completed a competitive process to procure Operators for the
27 Area's AJCs, known in the State of Ohio as Ohio Means Jobs Centers, and in Summit County as
28 the Ohio Means Jobs Summit County Center, and in Medina County as the Ohio Means Jobs
29 Medina County Center; and

31 WHEREAS, this Council previously approved Resolution No. 2016-326 authorizing the
32 Executive to execute an intergovernmental agreement with Medina County to create the Summit
33 and Medina Workforce Area Council of Governments, to execute bylaws for said council of
34 governments and to execute a Local Governance Agreement for Local Workforce Development
35 Area 2; and

37 WHEREAS, this Council subsequently approved Resolution No. 2017-347 authorizing
38 the Executive to execute a One-Stop Operator Services contract with the SAMWA COG
39 pursuant to which the Department of Job and Family Services ("DJFS") provided One-Stop
40 Operator services at the Ohio Means Jobs Summit County Center, with a term that commenced
41 with the execution of the contract through 6/30/20, inclusive of the renewal periods; and

43 WHEREAS, this Council subsequently approved Resolution 2020-260 authorizing the
44 Executive to execute a One-Stop Operator Services contract with the SAMWA COG pursuant to
45 which DJFS will provide One-Stop Operator services at the Ohio Means Jobs Summit County
46 Center, for a one year term, from 7/1/20 through 6/30/21, with two options to renew for an
47 additional one-year term, for which the County shall be paid an amount not to exceed
48 \$228,109.71; and

4 WHEREAS, the Executive wishes to execute a renewal (first of two) of a One-Stop
5 Operator Services contract with the SAMWA COG, pursuant to which DJFS will provide One-
6 Stop Operator Services at the Ohio Means Jobs Summit County Center, for the period 7/1/21
7 through 6/30/22, for which the County shall be paid an amount not to exceed \$228,110.00,
8 subject to confirmation by this Council; and

9
10 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
11 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
12 execute a renewal (first of two) of the One-Stop Operator Services contract with the SAMWA
13 COG, pursuant to which DJFS will provide One-Stop Operator services at the Ohio Means Jobs
14 Summit County Center, for the period 7/1/21 to 6/30/22, for which the County shall be paid an
15 amount not to exceed \$228,110.00; and

17 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
18 of Ohio, that:

20 SECTION 1

21
22 The Executive is hereby authorized to execute a renewal (first of two) of the One-Stop
23 Operator Services contract and any other necessary related documents with the Summit and
24 Medina Workforce Area Council of Governments (“SAMWA COG”), pursuant to which the
25 Executive’s Department of Job and Family Services (“DJFS”) will provide One-Stop Operator
26 services at the Ohio Means Jobs Summit County Center, for a one year term, from 7/1/21
27 through 6/30/22, for which the County shall be paid an amount not to exceed \$228,110.00.

29 SECTION 2

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the residents of the County of Summit, and for the further reason to immediately
33 authorize the Executive to execute a necessary One-Stop Operator Services contract with the
34 SAMWA COG, so that DJFS may immediately provide said services at the Ohio Means Jobs
35 Summit County Center.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

43 SECTION 4

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
48 were in meetings open to the public, in compliance with all legal requirements, including Section
49 121.22 of the Ohio Revised Code.


