WHEREAS, this Edward Byrne Memorial Justice Assistance grant will fund a countywide drug unit task force which will specifically target the manufacture, distribution and acquisition of illegal drugs in Summit County; and

WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit County Drug Unit checking account; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned Edward Byrne Memorial Justice grant from the ODPS-OCJS;
