7 **A Resolution authorizing the Executive to execute any documents necessary to accept the**  
8 **award from the State of Ohio Department of Rehabilitation and Correction of a Targeted**  
9 **Community Alternatives to Prison grant for State Fiscal Years 2022-2023, the period 7/1/21**  
10 **through 6/30/23, in the amount of \$2,970,663.00, with no local cash match requirement for**  
11 **the Executive's Department of Law and Risk Management – Division of Public Safety, and**  
12 **declaring an emergency.**

13  
14 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (“ODRC”)  
15 has created the Targeted Community Alternatives to Prison (“TCAP”) grant program to provide  
16 funding to local communities to effectively supervise, provide treatment services and hold  
17 accountable low-level, non-violent felony offenders in the community; and

18  
19 WHEREAS, the Executive, Sheriff and the Administrative Judge of the Court of  
20 Common Pleas-General Division, have agreed on a plan to use this funding to enhance  
21 programming and supervision alternatives to be able to maintain the TCAP population locally;  
22 and

24 WHEREAS, ODRC has awarded to the County of Summit a TCAP grant for State Fiscal  
25 Years 2022-2023, for the period 7/1/21 through 6/30/23 in the amount of \$2,970,663.00, with no  
26 local cash match requirement; and

28 WHEREAS, it is necessary for Executive to execute documents necessary to accept the  
29 grant award; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
32 that is it necessary and in the best interest of the County of Summit to authorize the Executive to  
33 execute any documents necessary to accept the State Fiscal Years 2022-2023 TCAP grant funds  
34 in the amount of \$2,970,663.00, with no local cash match requirement;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

15 effect and be in force at the earliest time provided by law.
