7 **A Resolution authorizing the Executive to execute any documents necessary to accept the**
8 **award from the State of Ohio Department of Rehabilitation and Correction, through the**
9 **Community Corrections Act, of a 407 grant for State Fiscal Years 2022-2023, in the**
10 **amount of \$2,478,224.00, with no local cash match requirement, for community corrections**
11 **programs to be operated by the Summit County Adult Probation Department and Oriana**
12 **House, Inc., for the period 7/1/21 through 6/30/23, for the Executive's Department of Law**
13 **and Risk Management – Division of Public Safety, and declaring an emergency.**

15 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (ODRC),
16 through the Community Corrections Act ("CCA") grant program, has renewed the award to the
17 County of Summit of a 407 grant for State Fiscal Years 2022-2023, the period 7/1/21 through
18 6/30/23, in the amount of \$2,478,224.00, with no local cash match requirement, for community
19 corrections programs to be operated by the Summit County Adult Probation Department and
20 Oriana House, Inc., for the period 7/1/21 through 6/30/23; and

22 WHEREAS, it is necessary for the Executive to execute documents necessary to accept
23 the grant award; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that is it necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the CCA 407 grant funds in the amount of
28 \$2,478,224.00, with no local cash match requirement, for State Fiscal Years 2022-2023;

35 The Executive is hereby authorized to execute any documents necessary to accept the
36 award from the State of Ohio Department of Rehabilitation and Correction, through the
37 Community Corrections Act ("CCA") grant program, of a 407 grant for State Fiscal Years 2022-
38 2023, in the amount of \$2,478,224.00, with no local cash match requirement, for community
39 corrections programs to be operated by the Summit County Adult Probation Department and
40 Oriana House, Inc., for the period 7/1/21 through 6/30/23.

44 This Resolution is declared an emergency in the interest of the health, safety and welfare
45 of the residents of the County of Summit and for the further reason of immediately authorizing
46 the acceptance of the State Fiscal Years 2022-2023 CCA 407 grant funds.
