7 **A Resolution confirming the award by the Board of Control of a construction contract with**  
8 **Control Concepts of Ohio, LLC. for the HVAC System Upgrades Project at four County**  
9 **Buildings, all located in the City of Akron, in Council Districts 4 and 5, for an amount not**  
10 **to exceed \$74,440.00, for the Executive's Department of Administrative Services – Physical**  
11 **Plants, and declaring an emergency.**

12  
13 WHEREAS, the current HVAC systems at various County buildings need upgrades as  
14 their current systems are not compatible with Windows XP or Windows 7 which causes a serious  
15 security risk; and

16  
17 WHERE, the above referenced upgrades will be performed at the Animal Control  
18 Facility, the Safety Building, the Courthouse Annex and the Medical Examiner's Office, all  
19 located in the City of Akron, in Council Districts 4 and 5; and

20  
21 WHEREAS, the HVAC upgrades are exempt from competitive bidding as they will be  
22 paid for at Other Public Cooperative Purchasing Association Pricing rates pursuant to Section  
23 177.07(a)(11) of the Codified Ordinances of the County of Summit; and

25 WHEREAS, the Board of Control, at its meeting held on June 9, 2021, awarded a  
26 construction contract with Control Concepts of Ohio, LLC., at Other Public Cooperative  
27 Purchasing Association Pricing, for the HVAC System Upgrades Project, for an amount not to  
28 exceed \$74,440.00; and

29  
30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that the aforementioned construction contract with Control Concepts of Ohio, LLC. is necessary  
32 and in the best interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that;

39 The award by the Board of Control of a construction contract with Control Concepts of  
40 Ohio, LLC. for the HVAC System Upgrades Project, at four County Buildings, all located in the  
41 City of Akron, in Council Districts 4 and 5, for an amount not to exceed \$74,440.00, is hereby  
42 confirmed and the Executive is hereby authorized to execute said construction contract and any  
43 other necessary related documents.

8 authorizes a necessary contract for a HVAC system upgrades at four County buildings.

13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
14 effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
20 deliberations of this Council and any of its committees that resulted in such formal action, were

22 121.22 of the Ohio Revised Code.


