7 **A Resolution confirming the award by the Board of Control of a Temporary Assistance to**  
8 **Needy Families Agreement with Summit County Combined General Health District dba**  
9 **Summit County Public Health, to provide diaper bank services, from 6/1/21 through**  
10 **9/30/21, in an amount not to exceed \$75,000.00, for the Executive’s Department of Job and**  
11 **Family Services, and declaring an emergency.**

12  
13 WHEREAS, the Executive’s Department of Jobs and Family Services (“DJFS”) seeks to  
14 enter into a Temporary Assistance to Needy Families (“TANF”) agreement with Summit County  
15 Combined General Health District dba Summit County Public Health (“SCPH”) to provide  
16 diaper bank services; and

17  
18 WHEREAS, under this proposed agreement, SCPH will coordinate a county-wide diaper  
19 bank for distribution of diapers, wipes and pull-ups to TANF eligible individuals, in  
20 collaboration with DJFS and the Full Term First Birthday local collaborative; and

21  
22 WHEREAS, SCHP will also distribute diapers, child safety items, parenting essentials  
23 and related information at community resource fairs in Summit County for pregnant women and  
24 parents known as Community Baby Showers; and

25  
26 WHEREAS, the Executive wishes to enter into a TANF Agreement with SCPH to  
27 provide the above referenced services; and

29 WHEREAS, the Board of Control, at its meeting held June 23, 2021, awarded a TANF  
30 Agreement with SCPH, which is exempt from competitive bidding due to the provider’s  
31 subgrantee status, to provide diaper bank services, from 6/1/21 through 9/30/21, in an amount  
32 not to exceed \$75,000.00, subject to confirmation by this Council; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
35 that the aforementioned TANF Agreement with SCPH is necessary and in the best interest of the  
36 County of Summit;

38 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
39 of Ohio, that:

43 The award by the Board of Control of a Temporary Assistance to Needy Families  
44 (“TANF”) Agreement with Summit County Combined General Health District dba Summit  
45 County Public Health (“SCPH”) to provide diaper bank services, from 6/1/21 through 9/30/21, in  
46 an amount not to exceed \$75,000.00, is hereby confirmed and the Executive is hereby authorized  
47 to execute said agreement and any necessary related documents.
