A Resolution confirming the award by the Board of Control of a professional service contract with Oriana House, Inc., as a Best Practical Source, for community corrections services, for the period 7/1/21 through 6/30/23, in an amount not to exceed \$786,236.00, for the Executive's Department of Law and Risk Management – Division of Public Safety, and declaring an emergency.

The Ohio Department of Rehabilitation and Corrections ("ODRC") through the Community Corrections Act ("CCA") Grant Program has renewed an award to Summit County of a 408 program grant for State Fiscal Years 2022-2023 (7/1/21 - 6/30/23) in the amount of \$981,240.00 to support alternative community corrections programs for misdemeanor offenders in order to divert individuals from incarceration. These programs are managed by Oriana House, Inc., the Summit County Sheriff and the Summit County Court of Common Pleas. Costs for programming by Oriana House, Inc. are not to exceed \$786,236.00; and

WHEREAS, this Council previously adopted Resolution No. 2021-160, which authorized the Executive to execute any documents necessary to accept the award of the above referenced 408 grant; and

WHEREAS, Oriana House, Inc. is a Best Practical Source as they are recognized by the ODRC as the service provider on the CCA Grant application and they have provided similar community corrections for the County for years; and

WHEREAS, the Board of Control, at its meeting held June 23, 2021, awarded a professional service contract with Oriana House, Inc., as a Best Practical Source, for community corrections services, for the period 7/1/21 through 6/30/23, in an amount not to exceed \$786,236.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned professional service contract with Oriana House, Inc. is necessary and in the best interest of the County of Summit;
