7 **A Resolution appropriating funds totaling \$8,517,796.56 and adjusting appropriations**
8 **down \$207,172.52 in order to meet projected expenditures for the balance of 2021 as set**
9 **forth in Exhibit A, for the Executive's Department of Finance and Budget, and declaring**
10 **an emergency.**

12 WHEREAS, certain operations of the County of Summit require appropriations in the
13 amount of \$8,517,796.56 and adjusting appropriations down \$207,172.52 in order to meet
14 obligations for the balance of the 2021 calendar year as set forth in Exhibit A, attached to this
15 Resolution and incorporated herein as if fully restated; and

17 WHEREAS, this Council has determined by reviewing all pertinent information that the
18 appropriations contained in Exhibit A are immediately needed for operations of the County and
19 are necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The County Fiscal Officer is hereby authorized and directed to effect the appropriations
27 set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated and
28 establish funds 20072, 23151, 25551, 25621, 27701, 40234, 40251, and 43253.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the residents of the County of Summit and for the further reason that the
34 appropriations contained in Exhibit A are immediately needed for operations of the County.

36 SECTION 3

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
47 were in meetings open to the public, in compliance with all legal requirements, including section
48 121.22 of the Ohio Revised Code.




