7 **A Resolution authorizing the Executive to advertise for bids for a five-year HVAC**
8 **maintenance contract for the Animal Control Facility, located in the City of Akron, in**
9 **Council District 5, for an estimated total cost not to exceed \$65,000.00, for the Executive's**
10 **Department of Administrative Services – Physical Plants, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2016-391, which confirmed
13 the award by the Board of Control of a five-year HVAC maintenance contract with K-Company,
14 Inc., for the Animal Control Facility, located in the City of Akron, in Council District 5, in an
15 amount not to exceed \$64,000.00; and

17 WHEREAS, the aforementioned maintenance contract with K-Company, Inc. expires on
18 10/31/21; and

20 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
21 requires this Council's authorization for the Executive to advertise for bids; and

23 WHEREAS, the Executive wishes to advertise for bids for the aforementioned five-year
24 HVAC maintenance contract for the Animal Control Facility, for an estimated total cost not to
25 exceed \$65,000.00; and

27 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's Office;

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that is necessary and in the best interest of the County of Summit to authorize the Executive to
32 advertise for bids for a five-year HVAC maintenance contract for the Animal Control Facility,
33 for an estimated total cost not to exceed \$65,000.00;
