7 **A Resolution confirming the award by the Board of Control of professional service**
8 **contracts with certain providers of delinquent care and custody grant services, for the**
9 **period 7/1/21 through 6/30/22, in a total amount not to exceed \$1,045,584.00, for the Court**
10 **of Common Pleas-Juvenile Division, and declaring an emergency.**

12 WHEREAS, the Court of Common Pleas-Juvenile Division has received a State Fiscal
13 Year 2022 Ohio Department of Youth Services Delinquent Care & Custody grant, in the amount
14 of \$4,845,611.74, for the period 7/1/21 through 6/30/22, that allows local courts to develop or
15 purchase a range of community based services to meet the needs of juvenile offenders or youth at
16 risk of offending; and

18 WHEREAS, the Board of Control, at its meeting held July 14, 2021, awarded
19 professional service contracts with certain providers, a complete listing of including the contract
20 amounts is attached to this Resolution as Exhibit A and incorporated herein as if fully restated,
21 for delinquent care and custody grant services, for the period 7/1/21 through 6/30/22, in a total
22 amount not to exceed \$1,045,584.00, subject to confirmation by this Council; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the aforementioned professional service contracts with certain providers are necessary and in
26 the best interest of the County of Summit;

28 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

33 The award by the Board of Control of professional service contracts with certain
34 providers, pursuant to Section 177.07(a)(12) of the Codified Ordinances of the County of
35 Summit, for delinquent care and custody grant services, for the period 7/1/21 through 6/30/22, in
36 a total amount not to exceed \$1,045,584.00 is hereby confirmed, and the Executive is hereby
37 authorized to execute the aforementioned professional service contracts and any necessary
38 related documents with the providers set forth in Exhibit A, which is attached to this Resolution
39 and incorporated herein as if fully restated.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit, and for the further reason to immediately
45 provide for delinquent care and custody grant services effective 7/1/21.

50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
