WHEREAS, the BHJJ grant allows collaboration with the Summit County Court of Common Pleas-Juvenile Division for the goal of decreasing commitments to the Ohio Department of Youth Services and on average, the grant serves 60 of the highest end youth per year; and.

WHEREAS, the Board of Control, at its meeting held June 14, 2021, awarded professional service contracts with certain providers for behavioral health and juvenile justice services, for the period 7/1/21 through 6/30/22, in a total amount not to exceed \$197,000.00, subject to confirmation by this Council; and

WHEREAS, a list of the aforementioned providers is set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned professional service contracts with certain providers are necessary and in the best interest of the County of Summit;
