7 **An Ordinance amending Section 169.07(d) of the Codified Ordinances of the County of**
8 **Summit entitled “On-Call Duty Pay,” to establish on-call pay for supervisors in the Adult**
9 **Protective Services Division of the Executive’s Department of Job and Family Services**
10 **responding to referrals or emergency situations outside the regularly scheduled workday,**
11 **for the Executive’s Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, Chapter 169.07 of the Codified Ordinances of the County of Summit
14 (“Codified Ordinances”), entitled “On-Call Duty Pay,” establishes on-call duty pay for certain
15 supervisor of the Executive’s Department of Sanitary Sewer Services; and

16

17 WHEREAS, the Executive’s Department of Job and Family Services, Division of Adult
18 Protective Services (“APS”) will begin to handle referrals and emergency situations arising
19 outside the regularly scheduled workday in August 2021, that were previously handled by a third
20 party provider; and

22 WHEREAS, it is necessary to establish on-call duty pay for supervisors in APS who will
23 respond to referrals or emergency situations outside the regularly scheduled workday; and

25 WHEREAS, the Executive desires to amend Section 169.07(d) to be consistent with the
26 amounts for on-call duty pay to bargaining unit employees in APS; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to amend Section 169.07(d)
30 of the Codified Ordinances, entitled “On-Call Duty Pay,” for the reason set forth above.

32 NOW, THEREFORE, BE IT ORDAINED, by the Council of the County of Summit,
33 State of Ohio, that:

35 SECTION 1

37 Section 169.07(d) of the Codified Ordinances, entitled “On Call Duty Pay,” is amended
38 to increase the authority of the Executive to establish on-call pay for supervisors in the Adult
39 Protective Services Division of the Executive’s Department of Job and Family Services
40 responding to referrals or emergency situations outside the regularly scheduled workday, as set
41 forth in Exhibit A which is attached hereto and incorporated herein by reference.

43 SECTION 2

45 This Ordinance is hereby declared an emergency in the interest of the health, safety and
46 welfare of the residents of the County of Summit and for the further purpose of immediately
47 amending Section 169.07(d) of the Codified Ordinances, entitled “On Call Duty Pay,” to
48 establish the rates of on-call duty pay for Adult Protective Services supervisors.
