7 **A Resolution authorizing the Executive to advertise for bids for the Medical Examiner's**  
8 **Facility Fencing Installation Project, located in the City of Akron, in Council District 4, for**  
9 **an estimated total cost not to exceed \$100,000.00, for the Executive's Department of**  
10 **Administrative Services-Physical Plants, and declaring an emergency.**

11  
12 WHEREAS, the Medical Examiner's facility has been experiencing an increase in  
13 vagrancy and security issues; and

14  
15 WHEREAS, the Medical Examiner's Facility Fencing Installation Project (the "Project")  
16 will install an eight foot high perimeter fence around the facility to secure the building and its  
17 occupants; and

18  
19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
20 requires this Council's authorization for the Executive to advertise for bids; and

21  
22 WHEREAS, the Executive wishes to advertise for bids for the aforementioned Project,  
23 for an estimated total cost not to exceed \$100,000.00; and

25 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's Office;

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 advertise for bids for the Project, for an estimated total cost not to exceed \$100,000.00;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The Executive is hereby authorized to advertise for bids for the Medical Examiner's  
38 Facility Fencing Installation Project located in the City of Akron, in Council District 4, for an  
39 estimated total cost not to exceed \$100,000.00.

43 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
44 of the residents of the County of Summit, and for the further reason that it authorizes the  
45 Executive to immediately advertisement for bids for necessary fencing for the Medical  
46 Examiner's Facility.

16 121.22 of the Ohio Revised Code.


