7 **A Resolution, subject to approval by the Board of Control, of a blanket purchase order**  
8 **with MNJ Technologies Direct, Inc., at State Term Pricing, subject to ratification by the IT**  
9 **Board, for information technology equipment, in an amount not to exceed \$116,147.50, for**  
10 **the Executive's Department of Job and Family Services, and declaring an emergency.**

11  
12 WHEREAS, the Executive desires to ensure that the Department of Job and Family  
13 Services has sufficient information technology equipment for use by its employees and  
14 recommends the approval of a blanket purchase order with MNJ Technologies Direct, Inc., at  
15 State Term Pricing, subject to ratification by the IT Board, for said equipment, in an amount not  
16 to exceed \$116,147.50; and

18 WHEREAS, the equipment purchased will include monitors, docking stations, headsets,  
19 keyboards and mouse sets to be used in a hybrid remote work environment; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that the aforementioned blanket purchase order with MNJ Technologies Direct, Inc., is necessary  
23 and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that:

30 The Executive is hereby authorized to execute, subject to approval by the Board of  
31 Control, a blanket purchase order with MNJ Technologies Direct, Inc., at State Term Pricing,  
32 subject to ratification by the IT Board, for information technology equipment, in an amount not  
33 to exceed \$116,147.50, and the Executive is hereby authorized to execute any other necessary  
34 documents related to said purchase order.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the residents of the County of Summit, and for the further reason to immediately  
40 provide for necessary information technology equipment for the Executive's Department of Job  
41 and Family Services employees to continue to provide services to the residents of Summit  
42 County.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.



10 121.22 of the Ohio Revised Code.


