7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, authorizing a blanket purchase order by the Executive from Robert Half**
9 **International, Inc., as a Best Practical Source, for temporary staffing services in calendar**
10 **year 2021, in a total aggregate amount not to exceed \$70,000.00, for the Executive's**
11 **Department of Law and Risk Management and the Executive's Department of Finance and**
12 **Budget, and declaring an emergency.**

14 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
15 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar
16 year, where no additional competitive quotes or bids have been taken, shall be made only upon
17 authorization of this Council; and

18
19 WHEREAS, the Department of Finance and Budget and the Board of Control have
20 previously approved the blanket purchase order by the Executive from Robert Half International,
21 Inc., as a Best Practical Source, for operations within the Executive's Department of Law and
22 Risk Management and the Executive's Department of Finance and Budget in calendar year 2021,
23 in a total aggregate amount less than \$50,000.00; and

25 WHEREAS, temporary staff provided by Robert Half International, Inc. are currently
26 working in the Executive's Department of Law and Risk Management processing attorney fee
27 applications and in the Executive's Department of Finance and Budget performing data entry for
28 a CARES Act program review; and

30 WHEREAS, the Executive anticipates making additional purchases from Robert Half
31 International, Inc. during calendar year 2021 and requests authorization to make blanket
32 purchases from Robert Half International, Inc., as a Best Practical Source, to continue using
33 experienced Robert Half International, Inc. temporary staff on existing projects for operations
34 within the Executive's Department of Law and Risk Management and the Executive's
35 Department of Finance and Budget in calendar year 2021, in a total aggregate amount not to
36 exceed \$70,000.00; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
39 that it is necessary and in the best interest of the County to authorize purchases by the Executive
40 from Robert Half International, Inc., as a Best Practical Source, for operations within the
41 Executive's Department of Law and Risk Management and the Executive's Department of
42 Finance and Budget in calendar year 2021, in a total aggregate amount not to exceed \$70,000.00;

44 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
45 of Ohio, that:

49 This Council hereby authorizes purchases by the Executive from Robert Half
50 International, Inc., as a Best Practical Source, for operations within the Executive's Department
51 of Law and Risk Management and the Executive's Department of Finance and Budget in
52 calendar year 2021, in a total aggregate amount not to exceed \$70,000.00.

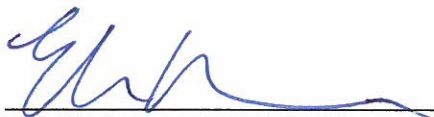

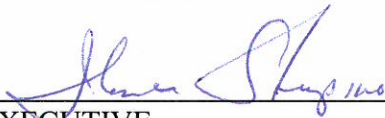
