7 **A Resolution confirming the award by the Board of Control of a blanket purchase order**
8 **with Ports Petroleum Co., Inc., at State Term pricing, for unleaded gasoline and diesel fuel**
9 **for general fleet operations and standby generators, in an amount not to exceed \$65,000.00,**
10 **for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

12 WHEREAS, the Executive's Department of Sanitary Sewer Services uses unleaded
13 gasoline and diesel fuel in County vehicles and standby generators, which requires the County to
14 purchase unleaded gasoline and diesel fuel; and

15
16 WHEREAS, the Executive wishes to enter into a blanket purchase order with Ports
17 Petroleum Co., Inc. for unleaded gasoline and diesel fuel for her Department of Sanitary Sewer
18 Services; and

20 WHEREAS, the Board of Control, at its meeting held on September 8, 2021, awarded a
21 blanket purchase order with Ports Petroleum Co., Inc., at State Term pricing, for unleaded
22 gasoline and diesel fuel for general fleet operations, in an amount not to exceed \$65,000.00,
23 subject to confirmation by this Council; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the blanket purchase order with Ports Petroleum Co., Inc. for unleaded gasoline and diesel
27 fuel for general fleet operations and standby generators is necessary and in the best interest of the
28 County of Summit;

30 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of a blanket purchase order with Ports Petroleum Co.,
36 Inc., at State Term pricing, for unleaded gasoline and diesel fuel for general fleet operations and
37 standby generators, in an amount not to exceed \$65,000.00, is hereby confirmed and the
38 Executive is hereby authorized to execute said blanket purchase order and any other necessary
39 related documents.

43 This Resolution is hereby declared an emergency in the interest of the health, safety, and
44 welfare of the residents of the County of Summit, and for the further reason to immediately
45 provide unleaded gasoline and diesel fuel for general fleet operations and standby generators for
46 the Executive's Department of Sanitary Sewer Services.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


