7 **A Resolution confirming the award by the Board of Control of a purchase contract with**  
8 **Buckeye Pumps, Inc., as a Best Practical Source, for a replacement Flygt pump for Waste**  
9 **Water Treatment Plant #25, located in Stow, in Council District 3, in an amount not to**  
10 **exceed \$28,337.00, for the Executive's Department of Sanitary Sewer Services, and**  
11 **declaring an emergency.**

13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit  
14 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar  
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon  
16 authorization of this Council; and

17  
18 WHEREAS, the Board of Control previously approved a blanket purchase order by the  
19 Executive's Department of Sanitary Sewer Services from Buckeye Pumps, Inc., as a Best  
20 Practical Source, for Flygt pumps and components, in an amount not to exceed \$50,000.00; and

21  
22 WHEREAS, the Executive wishes to purchase a replacement Flygt pump for Waste  
23 Water Treatment Plant #25, located in Stow, in Council District 3 in an amount not to exceed  
24 \$28,337.00 for a total not exceed of \$78,337.00; and

26 WHEREAS, Buckeye Pumps, Inc. is a Best Practical Source as they are the exclusive  
27 municipal distributor of Flygt pumps in Northern Ohio; and

28  
29 WHEREAS, the Board of Control, at its meeting held on September 8, 2021, awarded a  
30 purchase contract with Buckeye Pumps, Inc., as Best Practical Source, for a replacement Flygt  
31 pump for Waste Water Treatment Plant #25, located in Stow, in Council District 3, in an amount  
32 not to exceed \$28,337.00, subject to confirmation by this Council; and

34 WHEREAS, this Council finds and determines after reviewing all pertinent information  
35 that the aforementioned purchase contract with Buckeye Pumps, Inc., is necessary and in the best  
36 interest of the County of Summit;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
39 of Ohio, that:

43 The award by the Board of Control of a purchase contract with Buckeye Pumps, Inc., as a  
44 Best Practical Source, for a replacement Flygt pump for Waste Water Treatment Plant #25,  
45 located in Stow, in Council District 3, in an amount not to exceed \$28,337.00, is hereby  
46 confirmed and the Executive is hereby authorized to execute said purchase contract and any  
47 other necessary related documents.

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

23 121.22 of the Ohio Revised Code.


