7 **A Resolution confirming an award by the Board of Control of an agreement with Avenu, as**
8 **Best Practical Source, for Oracle and Banner Annual Support and Maintenance for the**
9 **period of 1/1/2022 to 12/31/2022 for a total price not to exceed \$233,144.24 for the Office of**
10 **Information Technology and declaring an emergency.**

12 WHEREAS, the County wishes to enter into an agreement with Avenu, as Best Practical
13 Source, for Oracle and Banner maintenance and support for a twelve-month term, from 1/1/2022
14 to 12/31/2022, in an amount not to exceed \$233,144.24; and

16 WHEREAS, the County of Summit Information Technology Board, after reviewing all
17 pertinent information, authorized the County Executive to enter into an agreement with Avenu,
18 for Oracle and Banner maintenance and support for a twelve-month term, from 1/1/2022 to
19 12/31/2022, in an amount not to exceed \$233,144.24;

21 WHEREAS, the Board of Control, at its meeting held September 15, 2021, awarded an
22 agreement, with Avenu as a Best Practical Source, for Oracle and Banner maintenance and
23 support for a twelve-month term, from 1/1/2022 to 12/31/2022, in an amount not to exceed
24 \$233,144.24 subject to confirmation by this Council; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned purchase contract with Avenu is necessary and in the best interest of the
28 County of Summit;

30 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of a purchase contract, with Avenu as a Best Practical
36 Source, for Oracle and Banner maintenance and support for a twelve-month term, from 1/1/2022
37 to 12/31/2022, in an amount not to exceed \$233,144.24, is hereby confirmed and the Executive is
38 hereby authorized to execute said purchase contract and any other necessary related documents.

42 This Resolution is hereby declared an emergency in the interest of health, safety and
43 welfare of the residents of the County of Summit, and for further reason to provide for necessary
44 software support and maintenance, for Oracle and Banner for the County, as expeditiously as
45 possible.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.


