7 **A Resolution designating PNC Bank N.A. as a depository of funds collected by the Clerk of**
8 **Courts pursuant to Section 2335.25 of the Ohio Revised Code for the period of 9/1/21**
9 **through 8/31/25, for the Executive and the Clerk of Courts and declaring an emergency.**

11 WHEREAS, Section 2335.25 of the Ohio Revised Code indicates that the Clerk of Courts
12 shall be the receiver of all funds payable into that office and that the Clerk of Courts may deposit
13 those funds into a bank subject to the security requirements of Section 131.11 of the Ohio
14 Revised Code; and

15
16 WHEREAS, the Clerk of Courts has maintained such a banking relationship with PNC
17 Bank, N.A. ("PNC") for such purposes and desires to renew the agreement with PNC to continue
18 to maintain such funds for a period from 9/1/21 through 8/31/25; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to designate PNC Bank N.A.
22 as a depository of Clerk of Courts funds for the period 9/1/21 through 8/31/25 and to authorize
23 the Executive to execute an agreement and any necessary related documents with that financial
24 institution;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

29 SECTION 1

31 PNC Bank N.A. is hereby designated as a depository of the Clerk of Courts funds for the
32 period 9/1/21 through 8/31/25, and the Executive is hereby authorized to execute an agreement
33 and any necessary related documents with that financial institution for the purpose of acting as a
34 depository of the Clerk of Courts funds.

36 SECTION 2

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the residents of the County of Summit and for the further reason that it is immediately
40 necessary in order for the County to timely designate PNC Bank N.A. as a depository of Clerk of
41 Courts funds for the period 9/1/21 through 8/31/25 and to authorize the Executive to execute an
42 agreement and any necessary related documents with this financial institution as a depository of
43 the Clerk of Courts funds.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


