7 **A Resolution declaring the week of October 17th - 23rd, 2021 as Stormwater Awareness Week**
8 **in Summit County, recognizing the effect stormwater has on our infrastructure and**
9 **environment in Summit County, for the Executive, and declaring an emergency.**

11 WHEREAS, urban stormwater runoff impacts water quality throughout Summit County;
12 and

13
14 WHEREAS, population growth, residential and commercial development, and the
15 resulting changes to the landscape will only increase stormwater quality and quantity concerns
16 throughout Summit County and Ohio; and

17
18 WHEREAS, these impacts cannot be entirely avoided or eliminated, but can be minimized;
19 and

20
21 WHEREAS, it is currently recognized that control of stormwater quantity and quality is
22 most effectively implemented when people and organizations understand the related causes and
23 consequences of polluted stormwater runoff and flooding, and the actions they can take to control
24 these; and

25
26 WHEREAS, the need arises not only from the regulatory requirements of EPA General
27 Construction and Municipal Stormwater rules, but also from the recognition that residents and
28 local decision makers will benefit from a greater awareness of how the cumulative impacts of
29 decisions at home, at work and through local policies impact our water quality, stream corridors
30 and flooding; and

32 WHEREAS, the development and implementation of effective, outcomes-based
33 stormwater education and outreach programs will meet the related federal stormwater pollution
34 control requirements and those of the communities they serve so that Summit County continues to
35 be a great place to live, work and play; and

37 WHEREAS, Summit County is committed to working collaboratively with its
38 communities and partners to better manage our stormwater, and is studying the use of federal
39 American Rescue Plan Act dollars to make once-in-a-lifetime investments in our stormwater
40 infrastructure; and

42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
43 that it is necessary and in the best interest of the County of Summit and its residents that the week
44 of October 17th - 23rd, 2021 be declared Stormwater Awareness Week in Summit County,
45 recognizing the effect stormwater has on our infrastructure and environment; and

47 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

18 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect
20 and be in force at the earliest time provided by law.

25 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
