7 **A Resolution authorizing the Executive to execute an Ohio Public Works Commission**  
8 **grant application and any other documents necessary to apply for and accept Local**  
9 **Transportation Improvement Program grant funds, in the amount of \$309,400.00, for the**  
10 **resurfacing of Killian Road from State Route 241 to just west of Myersville Road located in**  
11 **Springfield Township, in Council District 8, with no local cash match, for the Engineer,**  
12 **and declaring an emergency.**

13  
14 WHEREAS, the Engineer concludes that there is a public need for the resurfacing of  
15 Killian Road from State Route 241 to just west of Myersville Road located in Springfield  
16 Township, Council District 8, and

17  
18 WHEREAS, the County is eligible to acquire Ohio Public Works Commission Local  
19 Transportation Improvement Program (“LTIP”) grant funds, in the amount of \$309,400.00 for  
20 the resurfacing of Killian Road, with no amount necessary for local matching County road and  
21 bridge funds; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 execute an Ohio Public Works Commission grant application and any other documents necessary  
26 to accept and administer LTIP grant funds for the aforementioned purpose;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

32  
33 The Executive is authorized to execute an Ohio Public Works Commission grant  
34 application and any other necessary related documents required to accept and administer a grant  
35 for Ohio Public Works Commission Local Transportation Improvement Program (“LTIP”)  
36 funds, for the purpose of resurfacing of Killian Road from State Route 241 to just west of  
37 Myersville Road, in Springfield Township, in County Council District 8 (the “Project”).

39 SECTION 2

40  
41 The terms of said application shall request \$309,400.00 towards the construction cost of  
42 the Project from the Ohio Public Works Commission.

44 SECTION 3

45  
46 The Executive is authorized to execute said grant application necessary to apply for the  
47 aforementioned grant funds only for the Ohio Public Works Program Year 36, with further  
48 authorization required for any future grant applications for the purpose of resurfacing of Killian  
49 Road.

6 The Clerk of Council is instructed to provide two certified copies of this Resolution to the  
7 Engineer, for submission to the Ohio Public Works Commission with said grant application.

9 SECTION 5

11 This Resolution is hereby declared an emergency in the interest of the health, safety and  
12 welfare of the residents of the County of Summit, and for the further reason that it will allow the  
13 County to obtain grant funds for an immediately needed resurfacing project.

15 SECTION 6

16  
17 Provided this Resolution receives the affirmative vote of eight members, it shall take  
18 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
19 effect and be in force at the earliest time provided by law.

21 SECTION 7

23 It is found and determined that all formal actions of this Council concerning and relating  
24 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
25 deliberations of this Council and of any of its committees that resulted in such formal action,  
26 were in meetings open to the public, in compliance with all legal requirements, including Section  
27 121.22 of the Ohio Revised Code.


