7 **A Resolution authorizing the Executive to advertise for bids for a mobile surveillance tower**
8 **for Ohio Homeland Security Region 5 Law Enforcement for an estimated total cost not to**
9 **exceed \$165,000.00, for the Executive's Department of Law and Risk Management – Division**
10 **of Public Safety, Emergency Management Agency and declaring an emergency.**

12 WHEREAS, the mobile surveillance tower will be utilized at large gatherings throughout
13 the 13 counties within Ohio Homeland Security Region 5 to provide additional situational
14 awareness for law enforcement personnel; and

15
16 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires
17 this Council's authorization for the Executive to advertise for bids; and

18
19 WHEREAS, the Executive wishes to advertise for bids for a mobile surveillance tower for
20 Ohio Homeland Security Region 5 Law Enforcement for an estimated total cost not to exceed
21 \$165,000.00; and

23 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that is necessary and in the best interest of the County of Summit to authorize the Executive to
27 advertise for bids for the mobile surveillance tower.

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

34 The Executive is hereby authorized to advertise for bids for a mobile surveillance tower
35 for Ohio Homeland Security Region 5 Law Enforcement for an estimated total cost not to exceed
36 \$165,000.00.

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare
41 of the residents of the County of Summit, and for the further reason that it authorizes the Executive
42 to immediately advertise for bids in order to procure the necessary equipment within the grant
43 performance period.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
48 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
49 be in force at the earliest time provided by law.



10 of the Ohio Revised Code.


